

## Lake Association continued

Clay Dees was reelected Vice President and Sandy Schafer was elected secretary/treasurer. She was appointed in April when Margo Dees stepped down after 12 years of service.

There was discussion on the lake weed control project. Details are in another article.

## Weed control

Weed control issues in the lake continue to be a problem. There are a couple of issues to be aware of. First are non-native invasive species such as Eurasian Milfoil and Starry Stonewort. Both are below the surface and not easily noticed. Both are treated on a regular basis and if this wasn't done the weeds would overwhelm the lake in a few years.

Algae growth is recognized the most because it appears on the surface. Planktonic Algae, the floating green "pond scum", is seen in late summer especially on calm mornings following a light southern wind overnight.

The water volume in the lake is entirely from runoff from about 4,000 acres surrounding the lake. There are a lot

of nutrients washed into the lake, including yard fertilizers. Warm weather in the summer accelerates algae growth. Our engineering firm is seeing more algae throughout the state.

Unfortunately the lake will never be a clear lake. Residents have asked if there is anything else that can be done. The question has been asked of our engineering consultant, Rick Buteyn of Progressive AE. In part he responded:

"I certainly agree that Hardwood Lake was the clearest I have seen it earlier this year. The lake has been battling algae due to high nutrient concentrations for years now. Unfortunately, when conditions are favorable, algae growth can continue even

after treatment. Further, treatment has been restricted by the new permitting regulations set by EGLE. Previously, the lake could be treated up to 300' from shore for algae but the new permitted areas only extend 100' from shore. This has made algae treatments less effective.

It may be appropriate to consider a phosphorus reduction program going forward to try to curtail the algae growth on the lake. There are a couple of

approaches that may be appropriate:

1. Aluminum sulfate (alum). This would cost a significant amount, possibly in the hundred thousand dollars range. Alum is applied to strip the phosphorus out of the water column and create a very thin layer of phosphorus binding material on the lake bottom. A specialized barge is needed to apply the alum and the nearest company that does this work is based in Lincoln, Nebraska. We are currently pursuing alum treatments on two Michigan Lakes.

2. Phoslock (lanthanum). Phoslock is a granular product that is applied in a slurry to the lake. Similar to alum, lanthanum also binds phosphorus and creates a thin layer on the lake bottom. It is able to be applied by the commercial herbicide applicators, but a lake wide treatment would still be very expensive. This is a newer product and we are testing its efficacy near a nutrient laden inlet on Wiggins Lake in Gladwin. Morrison Lake has recently been conducting whole lake treatments using Phoslock with positive results.

3. Eutrosorb WC: "Proprietary aqueous blend" according to the manufacturer, but like lanthanum. Not approved for use in Michigan yet, so permitting and costs are unknown, but it appears to be a promising option for stripping phosphorus from the water column.

I think we should discuss this topic at our next meeting in order to plan for 2023.

According to Dave Sommers, our repre-

sentative on the Lake Improvement Board, Raising \$100,000 or more would be extremely difficult, requiring a costly special assessment. Rick has said that there is no guarantee the treatment would work for us and if it did there is no good idea of how long it would last.

We try to do an algae treatment before the three summer holidays when the lake receives the most use. Prior to the July 4th weekend there was an algae treatment. A few weeks later there was more floating planktonic algae and another treatment scheduled. There is a long stretch between July 4th and Labor Day. A treatment was applied on July 28 - within a few days algae returned. Rick was asked about this and replied in part:

"Based on the results of the last algae treatment and the fact that the planktonic algae growing in Hardwood Lake is across its entirety, I am concerned that we would have a similar situation to the last treatment where there was no noticeable difference post-treatment. We may only treat 100' from shore so the area of impact is quite limited. It would be helpful if we had some cool cloudy weather that would naturally reduce some of the algae growth. I look forward to meeting and discussing the lake management strategy with the group this fall."

Treatment maps are posted on the lake Facebook and web site.
