LAKE BOARD REPORT by Dave Sommers

After the collection of taxes the Richland Township treasure, Virginia Majors, refused to pay the bills of the Hardwood Lake Improvement Board. Majors then sued Richland Township

and the Lake Board claiming that it was not her responsibility to pay the bills. Keep in mind the Lake Board is a legal entity operating under the Richland Township board. The Hardwood Lake Improvement Board and Hardwood Lake Property Owners Association are two separate organizations.

Richland Township and the Hardwood Lake Improvement Board counter sued to force her to pay the bills. In the mean time the Ogemaw County Treasurer agreed to handle the money until the court ruled on the suit. The county would keep the interest on the money as their fee.

August 6th the judge ruled in favor of Richland Twp. And the Hardwood Lake Imp. Board. However no monetary awards were given, both Ms. Majors and Richland Twp. & Hardwood Lake Imp. Board would pay their own legal fees.

In mid May Adept Aquatic Weed Control treated the lake with herbicide to control the milfoil. In late June another spot treatment was made.

In early July Professional Lake Management harvested weeds from 25 acres of the lake. In late August they harvested another 25 acres.

An evaluation was to be made in late August regarding the algae on the lake surface.

In spring of 1997 another evaluation of the lake will be made and another course of treatment will be recommended. The treatment program will then be based on those findings.

High speed boating 11:00 a.m. to 7:30 p.m.


Skiers must be 100 feet away from docks and swimming area
