this year due to the low turn out.


THEREFORE there WILL NOT be a

## DEPARTMENT OF ENVIROMENTAL QUALITY

Certain restrictions that apply to the aquatic nuisance plant control permit.

A2, 4-D and/or granular endothall treatment program has been approved for Hardwood Lake waterbody in 1999. Please be aware that certain setbacks from private wells are required to protect drinking water supplies when using these chemicals. The setback requirements state that granular endothall or granular 2, 4-D products are not to be applied within 75 feet of ANY well OR within 250 feet of wells less than 30 feet deep. The permittee is responsible for locating the water wells and for observing the appropriate isolation requirements. All permits for 2, 4-D and granular endothall will have a specific permit condition reflecting these requirements.

We encourage you Lake Association or group of homeowners to work with the commercial applicator to identify the shallow wells and to locate all water wells that are subject to the permit condition. Our office will perform random audits during 1999 to verify that the proper information is being obtained for compliance with the drinking water well isolation permit condition.

Through the proper use of herbicides we can meet the recreational needs of riparians and protect the public health.

## BEETLES for Lake

**Treatment?** It was brought to our attention that other Michigan Lakes are using the Watermilfoil beetles to eliminate the milfoil in their lakes. Although, Progressive at that time said the Beetle program was relatively new and wanted to see how they did in other areas before recommending this as a possible solution for our lake.

An article written on Paradise Lake dated March 23, 1999 leaves hope that this could be a better solution to the chemical treatment for milfoil. Milfoil makes up about 50% of our weed problem. If this form of treatment were to be put in place the treatment of herbicide and harvesting would more than likely be disbanded due to the risk of killing the beetles with the chemical treatment and harvesting would more than likely kill or remove them from our lake.

Paradise Lake residents report by the end of the season even finding milfoil with a healthy stem. Boaters found the

lake much clearer and dramatic decrease in all tested areas. One female beetle can give rise to 40,000 to 50,000 others in the summer. Bugs were barely noticeable.

Doug Fuller, water resource program director with the Tip of Mitt Watershed Council, said the Beetle program was more cost effective and more environmentally sound than dousing the lakes with herbicides.

## RESIDENTS




